Location

The property is located in the popular Rosemount area of Aberdeen close to the city centre lying on the corner of Rosemount Viaduct and Gilcomston Park. Excellent amenities are within a relatively short walking distance and include the newly developed Union Terrace Gardens, His Majesty's Theatre, Aberdeen Art Gallery and the Bon Accord Shopping Centre.

Description

The building is of traditional granite stone over four storeys, attic and basement with a pitched slate clad roof.

Internally the offices are located within the lower ground floor accessed off Gilcomston Park and to the rear via the secure car park. The accommodation comprises a variety of office sizes with a reception/waiting area, meeting room facilities and tea prep. There is potential access to private car parking.

Use

The offices and other rooms are suitable for a number of uses and would suit a variety of occupiers. The property also benefits from ample storage.

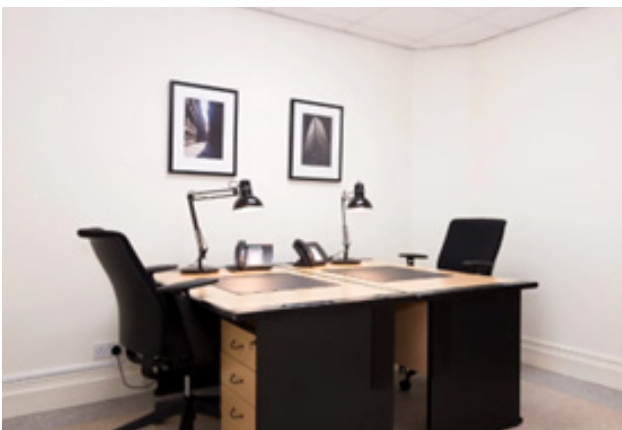
