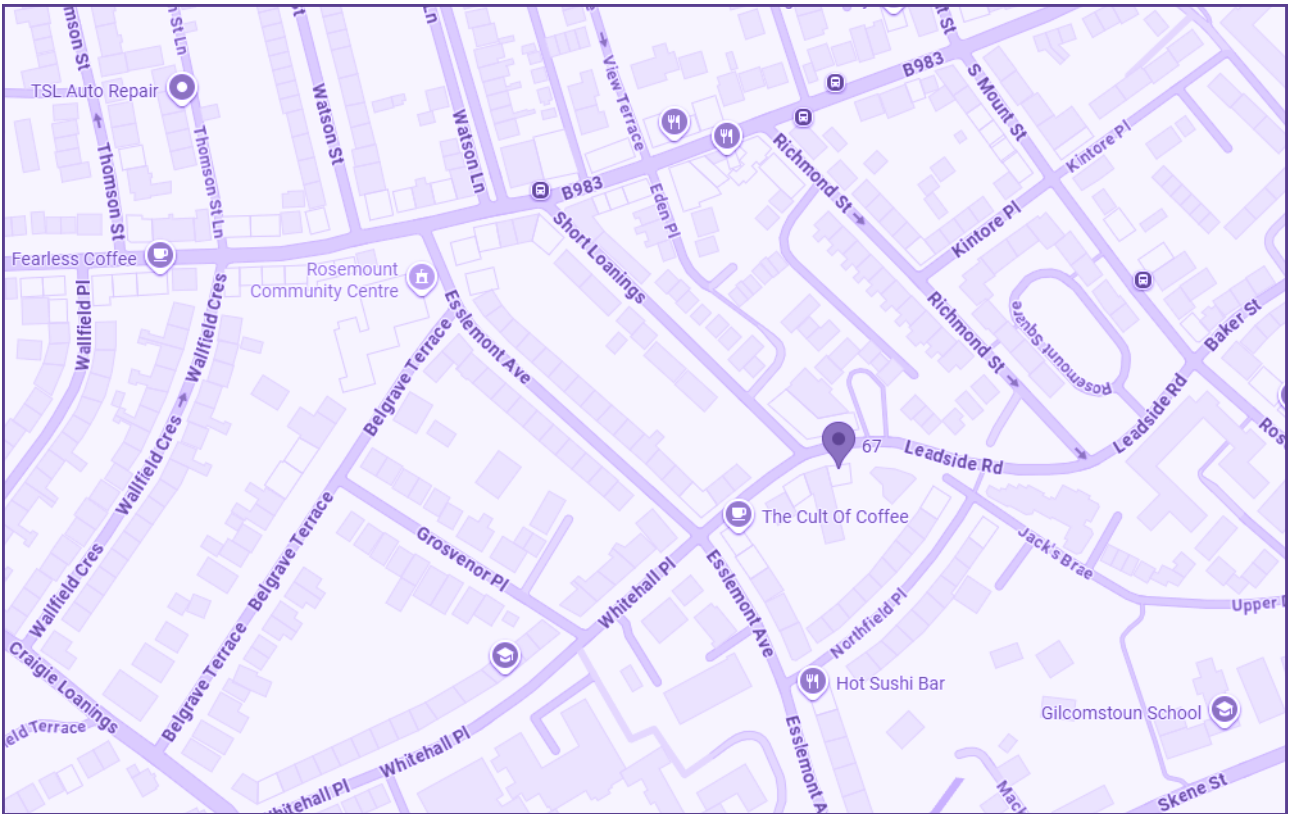

Location

The property is located in the popular Rosemount area of Aberdeen, just a short distance from the city's main commercial hub, Union Street. More precisely, it occupies a position on the south side of Leadside Road, near its junction with Eslemont Avenue. The surrounding area features a mix of residential properties and local commercial occupiers.

Description

The property consists of a builder's workshop/store located on the ground floor of a three-storey and attic stone building with a slate-clad mansard roof. To the rear, there is a single-storey extension and a patio area, both accessible directly from the workshop/store.

Internally, the accommodation provides basic workshop and storage space with concrete flooring and a combination of block and plasterboard walls. Ceiling heights vary throughout the unit, which also benefits from welfare facilities including a tea preparation area and WCs. An office is positioned towards the centre of the unit.
