Location

The site is located in the Garthdee area of Aberdeen, a primarily residential suburb approximately 2 miles to the southwest of the city centre. The site is bound by Ramsay Gardens to the west, Inchbrae Drive to the south, Aboyne Road to the east and Ramsay Place to the north.

The site is in close proximity to Robert Gordon University, Asda, Sainsbury's, Curry's, Boots, David Lloyd Leisure Club, B&Q and Aberdeen Adventure Snowsports.

Description

The property comprises a level, irregularly shaped site extending to circa 0.81 ac (0.33 ha). The site previously housed the Garthdee Parish Church, which was demolished in 2022, leaving a cleared site suitable for a range of development uses.
