



Location

This development is located in the suburb of Bridge of Don, home to a community of 19,500 residents. Located just 4 miles north of Aberdeen City, it benefits from excellent transport links, providing access to both the north and south.

The unit is positioned on the first floor of the Braehead Way Shopping Centre within close proximity to Bridge of Don Academy.

Occupiers within the centre include Morrisons Local, Ledingham Chalmers Solicitors, Porters Pharmacy and Charles McHardy Butchers. The upper floors are predominantly occupied by health and wellbeing related services.

Description

The subjects form part of a two storey neighbourhood retail parade.

Accessed exclusively from ground floor, the suite provides upper floor accommodation previously used as offices.

Internally, the suite provides a mix of open plan and cellular rooms but could be opened up further, subject to planning.

WC's and a tea prep area lie to the rear with a fire exit. The subjects are finished to a relatively good standard but would benefit from a degree of upgrading.
