

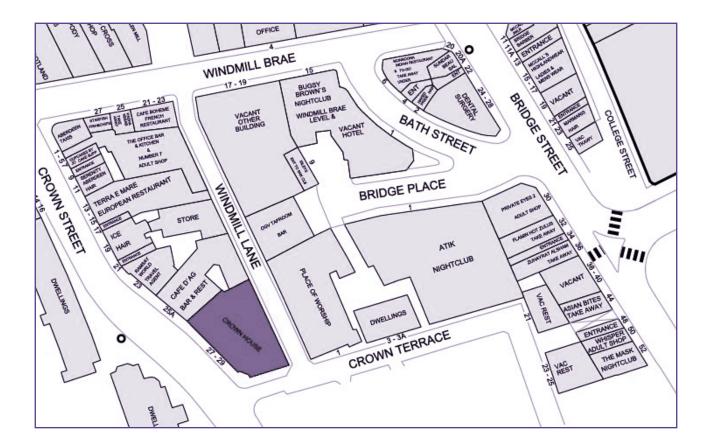

## Location

The unit on offer is situated within Crown House located within Aberdeen City Centre at the junction of Crown Street and Crown Terrace.

Crown House is a short walk from Union Street, the city's main commercial thoroughfare which is popular with local and national traders.

Occupiers in the vicinity include Ramsay World Travel, The Stag Public House and Shelter Scotland. The area has also seen a considerable redevelopment of residential properties.

# Description

Recently refurbished, the unit provides a unique open plan layout suitable for a variety of uses. The unit comprises painted plasterboard walls, suspended tile ceiling with censored LED lighting. Heating is provided by a gas central heating system serving wall mounted radiators. There is a kitchen to the rear with an accessible WC.
