



Location

The unit forms part of a small industrial development on the east side of Hillview Road, Tullos close to Wellington Road, a main arterial route within Aberdeen and within close proximity to the city centre.

Occupiers within the vicinity include, Arnold Clark, Car Clinic, Steveweld, Peter Vardy and John Clark.

Description

The unit is of steel frame construction with block and insulated sheeting walls. The roof is of insulated sheeting.

Internally there is warehouse and cold stores together with ancillary offices at ground floor with additional storage provided at first floor level. Heating is provided by way of a warm air blower in the warehouse and radiators in the offices. The cold store and chills areas are lined and have the requisite chilling plant. Details on request.

Vehicular access is by means of two roller shutter doors and there is exclusive car parking (10 spaces) and a communal yard.
