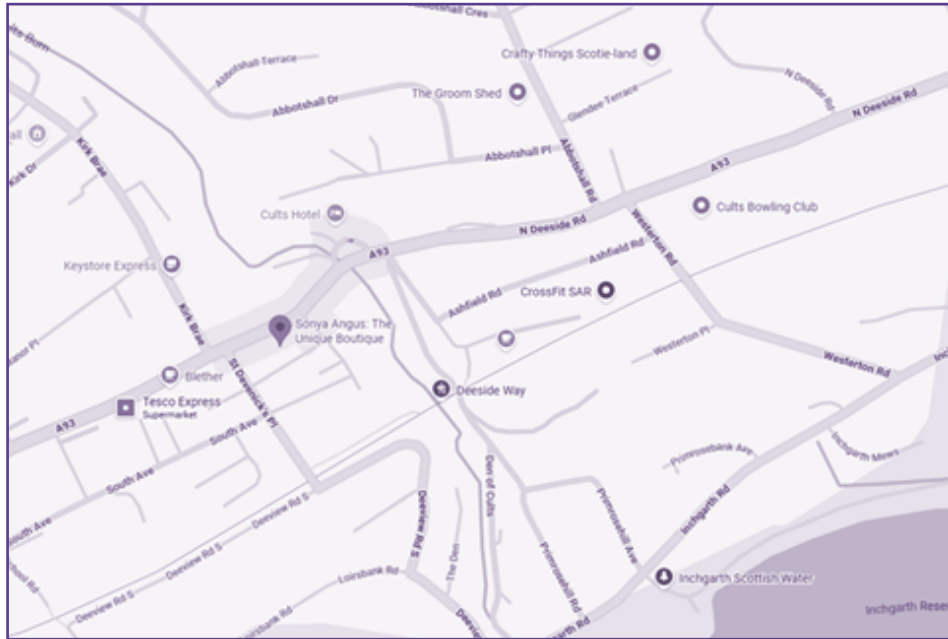

Location

The property is located within the affluent suburb of Cults, approximately 3.5 miles west of Aberdeen city centre. More specifically, the unit is accessed off Millden Road, to the rear of the main retail parade.

Nearby occupiers comprise a mix of national and local operators, including Domino's, Costa, Subway, and Scott Gilmour Optometrists.

Description

The unit occupies an end-terrace position within the retail parade and benefits from a glazed frontage, accessed via a single entrance door.

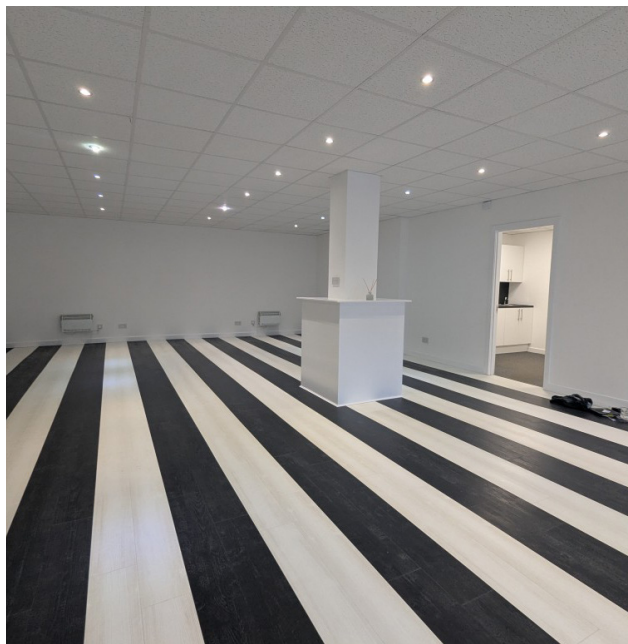
Internally, the accommodation is arranged to provide predominately open plan retail space with ancillary areas including an accessible WC and office/staff/tea-prep area.

Customer parking is available within the scheme.

Rent
