Location

The subjects are located in a strategic position adjacent to the main A90 Aberdeen to Dundee trunk road, two miles north of the commuter town of Portlethen and five miles south of Aberdeen City Centre.

Situated on the west side of the A90 it benefits from direct road access both north and south. Transport links have been further enhanced with the opening of the AWPR, with slip road access immediately adjacent to the site.

The above plan shows the current layout of the site in proximity to the AWPR which has been provided for indicative purposes only.

Description

The site is approximately square in shape with immediate access off Duffshill Road. Main services will be available to the site and it will be enclosed by earth bunding approximately 3m in height.

The site will be scraped, serviced and ready for development.

Planning

The site is currently designated for Waste Management and Associated Employment Uses within the Aberdeenshire Local Development Plan 2012. A planning application has been submitted to obtain Planning Permission in Principle for the development of further waste facilities and associated employment uses. Further information can be provided to interested parties on application.
