Location

Peterhead is located some 30 miles north of Aberdeen with further links north via the A90 to Fraserburgh. Peterhead benefits from a population of circa 24,000 persons.

The subjects are located on the south side of the A90 within Upperton Industrial Estate, which sits on the south side of Peterhead close to its junction with the A982. The estate benefits from direct access to the A90 providing good transport links to Aberdeen, Fraserburgh and beyond.

The precise location has been shown on the above plan which has been provided for indicative purposes only.

Description

The subjects provide a hardcore surfaced site which is secured by way of steel palisade chainlink fencing and gates. Services are available to the site and there are CCTV security cameras currently in place.

Planning

The site benefits from having Class 6 (Storage & Distribution) use consent. Other uses may be considered on the site subject to obtaining the necessary planning consents.
