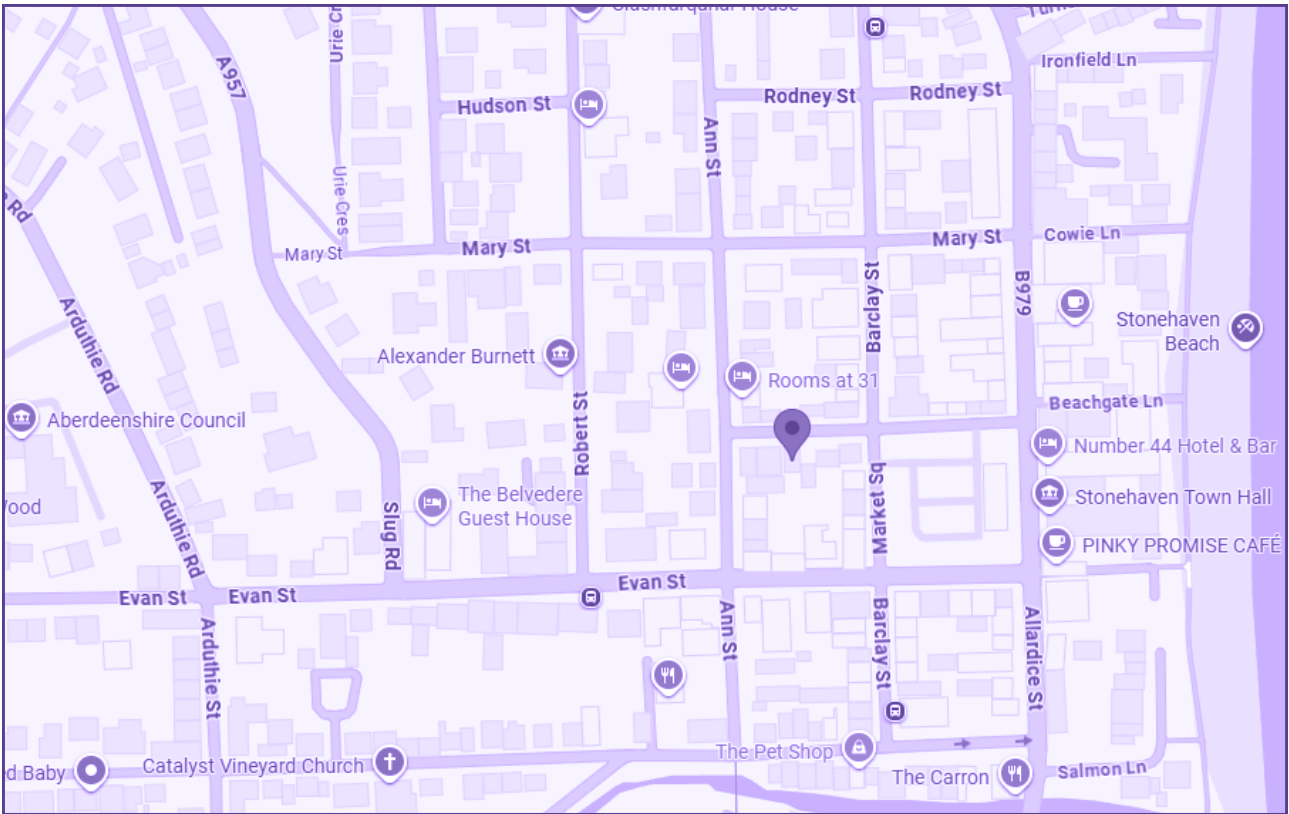

Location

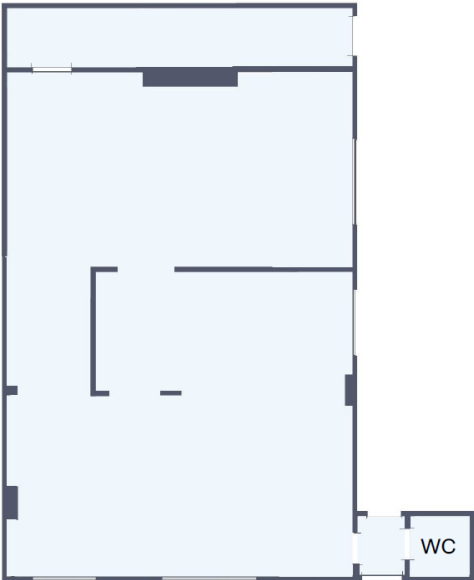
The property is located within the coastal town of Stonehaven, approximately 15 miles south of Aberdeen city. The subjects lie on the south side of Margaret Street within the town centre, perpendicular to The Square.

Nearby occupiers include Charles Michie Pharmacy, Chest Heart & Stroke Boutique and local operators.

Description

The subject comprises a single storey ground floor retail unit of block construction and a roughcast finish. The property sits under a pitched and slated roof and has two retail windows which fronts Margaret Street.

Internally, the property is largely open plan in nature with a WC off the main entrance. There is an external courtyard exclusive to the property accessible from a rear door and gate off Margaret Street.
